FROM THE SECRETARIAT

Social Justice Sunday – 30 September

As Social Justice Sunday approaches, now is the time to place your orders for the Australian Catholic Bishops' Statement. Bishop Christopher Saunders, Chairman of the ACSJC has called on all Catholics and people of good will to ponder the question posed by the young lawyer to Jesus in the Gospel of St Luke, 'Who is my neighbour?' As individuals and as a nation, we are invited to consider the response Jesus gave in the parable of the Good Samaritan.

In the Chairman's message, Bishop Saunders suggests we take the time to contemplate the diversity of people around the world and the particular circumstances of joy and hardship in their lives.

‘Through this amazing diversity,’ the Bishops says, ‘we are all sisters and brothers of this world – created in the image and likeness of God. The life we share is sacred and our human dignity is to be respected’.

This variety also reflects the importance of multiculturalism in Australia. ‘Our multiculturalism is an aspect of national life that makes Australia great; reflecting our solidarity with all peoples of the world and a generosity of heart in responding to those in need’. The Bishop goes on to ask ‘And what of the circumstances of many of our Indigenous sisters and brothers who continue to endure third-world conditions in this land of plenty?’

He says we are all called to recommit ourselves to our neighbours and to act in the interests of people who do not share our prosperity and security.

2007 Federal Election resources

The Australian Catholic Bishops have urged Catholics to consider the common good when casting their vote in the forthcoming federal election. In their statement ‘A Vote For Us All’ the Bishops raise some key issues for people to consider.

‘Catholic tradition holds that the common good is underpinned by the promotion and protection of human dignity. Implicit in seeking the common good is the desire to serve the poor, the marginalised, the sick and the forgotten in our society,’ the Bishops say.

The issues addressed in the Bishops’ election document include: the sanctity of human life; the needs of refugees and asylum seekers; the rights of working families; access to quality education; the need to achieve lasting dignity and justice for Indigenous peoples; access to quality health care; environmental responsibility; and the promotion of generous overseas aid policies. The ACSJC has produced a leaflet, ‘A Vote for Social Justice’ which highlights some key justice issues and provides an outline of the Australian Catholic Bishops’ priority issues for the federal election.

The leaflet aims to help you think about some important issues that will be decided in this election and offers some questions that you could raise with all candidates in your electorate.

Some of these issues aren’t the ones you will see in headlines or hear about from parties, but they are still crucial in shaping what kind of society we all live in.

Issues are discussed under the headings ‘Justice for Indigenous people’, ‘Justice in the workplace’, ‘Justice for those made poor’, ‘Justice for asylum seekers’ and ‘Climate and the environment’. Poverty in Australia

A new report by Australia Fair shows that the number of Australians living in poverty has increased over the past 10 years. Using an international poverty line based on median income, the numbers in poverty increased from 7.6% to 9.9% of the population between 1994 and 2004, or nearly 2 million Australians.

Andrew Johnson, spokesman for Australia Fair says, 'In the current good economic times, with a large budget surplus, it's not fair that 2 million Australians are struggling to access necessities like affordable housing and dental care.'

John Falzon, CEO of the St Vincent de Paul Society's National Council says, 'Governments need a comprehensive plan with targets to tackle disadvantage in Australia, which is the approach taken in 22 out of 30 OECD countries.'

The report examines 10 areas such as health, education, housing and work, which were identified by the Australian public as essential to ensure a fair go for all Australians. To download the report, visit: <http://www.australiafair.org.au>

Those with a concern for the many groups who have not fared well during the sustained period of national prosperity will find of interest the report launched earlier this year by Catholic Social Services Australia and Jesuit Social Services.

Professor Tony Vinson is the author of the report 'Dropping off the Edge', which finds that the top three per cent of the most disadvantaged communities in Australia (68 in all) have double the rate of unemployment and two and a half times the rate of long term unemployment of other communities. These communities have almost double the rate of disability support and psychiatric admissions and more than double the rate of criminal convictions and approaching three times the rate of imprisonment.

Their proportion on confirmed child maltreatment cases is more than 3.5 times that of the remaining localities.

The author and commissioning organisations hold that these disparities demand immediate and sustained remedial action and show that the many complex and difficult circumstances are not beyond our influence. The motivation for the research comes from many decades of experience working with young Australian families.

Catholic Social Services Australia called on the Federal Government to raise pension levels to substantially more than the current 25% of average male earnings.

Federal Govt resurrected Sir Joh: Brennan claims

Jesuit Professor Frank Brennan compared the new Federal Government policies for Indigenous communities with those promoted thirty years ago by the late Queensland Premier Sir Joh Bjelke-Petersen.

Mugabe support "sickening": Sth African bishop

South African Bishop Kevin Dowling said that Zimbabwe President Robert Mugabe had "destroyed" the country.

Vatican agency attacks "cruel, unnecessary" death penalty

A report published by the Holy See Congregation for the Evangelisation of Peoples described the death penalty as "cruel and unnecessary".

Pakistan Christian girls forced to convert to Islam, marry Muslims

Two Christian girls aged 11 and 16 were kidnapped, forcibly converted to Islam, and married off to Muslim strangers.

Social justice emphasis wins ethics prize

The Australian Catholic University's 2007 Eureka Prize for Research in Ethics was awarded to Macquarie University's Dr Catriona Mackenzie.

Sydney Catholic College quits Amnesty

The Jesuit headmaster of Sydney's St Aloysius College confirmed that his school will sever its ties with Amnesty International.

Bishop resigns as Amnesty backs abortion

British Catholic Bishop Michael Evans resigned from Amnesty International after the international human rights organisation approved a new policy affirming the right to abortion under limited circumstances.

Wage decision discriminates against families: ACCER

The Australian Catholic Commission for Employment Relations said the Industrial Relations Commission's decision on the Federal Minimum Wage discriminates against low paid workers with family responsibilities.

Time out needed on Indigenous legislation: Catholic Social Services

Condemning the lack of consultation on the Federal Government's Northern Territory Indigenous legislation, Catholic Social Services Australia chief, Frank Quinlan, insisted on two months of deliberation before passage of the bills presently before Parliament.

Pope exhorts Catholics to fight the "dragon" of materialism

Likening materialist ideologies including consumerism to the red dragon of the biblical Book of Revelation, Pope Benedict reminded his Feast of the Assumption audience that "love is stronger than evil" and God more powerful than the dragon.

No going back to square one on indigenous issues: Caritas chief

Caritas Australia CEO, Jack de Groot, backed the Federal Government's immediate intervention to stop violence and child abuse in Indigenous communities but warns that the Government should not "fall into the trap of going back to square one".

Wilson focuses on politicians' personal qualities

In questions to Australia's political leaders during an Australian Christian Lobby webcast, Australian Bishops president, Archbishop Philip Wilson asked Prime Minister Howard and Opposition leader Rudd to identify the personal qualities required for "authentic leadership".

Index rent assistance: Catholic Social Services

Citing increasing numbers of low income people who are being forced to choose between paying for food, heating and rent, Catholic Social Services called on the Government to index rent assistance for people in the private rental market.

Hasten slowly on Indigenous welfare: Catholic Social Services

At least two months is needed for genuine consultation on draft legislation introduced into Federal Parliament by Indigenous Affairs Minister Mal Brough, said Catholic Social Services chief Frank Quinlan.

Philippines mayor calls on bishop to oppose Aussie mines

Blaming two Australian mining companies for hardships experienced by villagers in several remote Philippines villages, a town mayor called on the local Catholic bishop for backing in his "lonely fight" against the mines.

Maintain GM ban, Columban centre argues

Citing concern that states are set to lift a series of moratoriums on the planting of genetically modified food crops, a Sydney-based Columban justice centre called on Australians to lobby their state parliaments to extend the bans.

Take democracy seriously, Catholic bishops say

In a pre-election statement calling for "fair industrial laws" and an end to Aboriginal child abuse, Australian bishops have urged Catholics to get involved in the political process to promote the "common good" and not just their own individual interests.

Don't forget Papua: Melbourne bishop

A Melbourne bishop well known for his support for Timorese people, Bishop Hilton Deakin, called on Australians to remember the role played by Papuans in assisting Australia during World War II and urged Australia to resist human rights abuses in the region.

Govt to appeal "inadequate" Pine Gap fines

The Commonwealth Director of Public Prosecutions lodged an appeal against a "manifestly inadequate" fine imposed on Pine Gap Four protestors by the NT Supreme Court and is seeking a custodial sentence.

Time to move on environment, lay leader says

The Vatican and religious congregations gave a lead on environmental issues but "now it's time to mobilise the whole church starting with the laity", said MJ Ruben, an Indian lay movement leader.
