### FROM THE SECRETARIAT

Dear Friends,

At the end of a busy year the Church enters a new liturgical year with the Season of Advent.

Advent is a time for reflection and taking stock of our lives as we approach the Christmas Season. It is a time of expectation - of listening for the invitation to discover once more the saving presence of God in our lives. And, with the dramatic image of the nativity, we appreciate the great significance of God becoming one of us in the person of Jesus Christ.

The weeks of Advent would help us to receive the true gift of Christmas and to prepare for the year ahead. However, it stands almost prophetically against the busyness and consumerism associated with the coming weeks. The Season offers us the opportunity to stop, listen and receive the meaning of Christmas. But, in fact, our days become more hectic and we are encouraged to spend, spend, spend!

This is not to say there is no place for gifts, festivities and great meals with family and friends. But the mad rush and panic buying does not lend itself to preparing the way of the Lord.

Think of the shopping experience many will have in the weeks before Christmas. Bouts of road rage in full-to-overflowing car parks. Retail staff working absurd hours and forced to endure the never-ending cycle of carols piped through the shopping centre. Entire families on slow moving check-out lines. Children who are pump-primed by advertisers to grasp for the latest and best.

It is sad that media marketing has all but eclipsed the Season of Advent. But the competitive spirit of the market has also distorted the meaning of Christmas. Recently I was picking my daughter up from school and I heard a child ask her father, 'Dad, who do you like best - Jesus or Santa?' Slightly shocked, thinking on his feet and not wanting to deny the existence of 'Santa' in front of the other kids, the father said, 'You know that Jesus gives you a gift that that won't break, that lasts all your life and you can take with you even if you die.' The beautiful thing I noticed in that instant was that the little girl had a look of understanding in her eyes and said 'yes'.

I would like to think that amid the hectic consumerism, the true meaning breaks through - even in brief glimpses. The vivid Gospel stories about the Holy Family have the power to penetrate the hype. Mary, one of the *anawim* - the little people - was chosen to be the Mother of God. Against the convention of the day, Joseph married Mary and became the father of her unborn child. Rejected at the Bethlehem inn, Mary gives birth to her child in a stable. The flight into Egypt, away from the threat of Herod, is another reminder that along with the great joy of Jesus' birth were significant risks, threats and great hardships.

In the rowdiness of the period, these Gospel passages about the Holy Family call us to bear in mind those who are in very difficult circumstances and experiencing loneliness or despair. So, this Advent, we might hold in our thoughts and prayers any families who are struggling. Let us pray: For families struggling financially who may have lost livelihoods and be facing homelessness; For those fleeing war, oppression and famine; For those experiencing the sadness of family breakdown, separation and divorce; For those experiencing ill-health or who have lost loved ones. And for those who have no families. Let us pray.

In particular at this time, I invite you to hold in your prayers Christine and Lee Rush of Corinda Parish in Brisbane. You would be aware that their son Scott, along with Andrew Chan and Myuran Sukamaran, currently faces the death penalty in Indonesia. Let us pray that they will

be spared from a penalty that is so contrary to our understanding of life as a gift from God. Please pray also for Chris and Lee's other son, Dean, who has just undergone surgery and is very ill. Prayers also for Fr Tim Harris and the Corinda-Graceville parish who have been a great support to Chris and Lee through this difficult time. They need our prayers and I ask you to remember them when you go to Mass this Christmas.

Advent is a time for kindness, thinking of others, and serving those in need. May this Advent bring you joy and provide the opportunity for a deep awareness of God being with you and your loved ones.

### **ACSJC - 'DEATH PENALTY DEBATE MUST RESTORE CONSISTENCY'**

The Australian Catholic Social Justice Council has called on Federal Parliament to hasten the debate regarding the death penalty. The ACSJC supports the notice of motion by Chris Hayes MP, Member for Werriwa, for Australia to adopt a stronger and more consistent stance against capital punishment. ACSJC Chairman, Bishop Christopher Saunders, said the parliamentary debate would provide an opportunity for leaders of all political parties to confirm Australia's opposition to capital punishment and to renew efforts for the universal abolition of the death penalty. 'The ACSJC holds that a strong, principled rejection of capital punishment anywhere in the world - regardless of who the accused is or the nature of their crime - would improve Australia's ability to protect and represent Australian citizens who are exposed to the death penalty overseas.

'We believe that the values upon which capital punishment is to be opposed are such that no exceptions should be made at home or abroad. Australia's opposition to the death penalty cannot end at our national borders,' Bishop Saunders said. ### **EDMUND RICE CENTRE - ONLINE PETITION**

Following the screening of *A Well-Founded Fear* on SBS, Edmund Rice Centre director, Phil Glendenning has called today called for Australians to make known to the Federal Government, their support for the process of reform of the Howard Government's immigration regime and its inhuman treatment of asylum seekers. Responding to the calls for action Mr Glendenning said: 'There are three ways people can help. The first and simplest thing is to sign the online petition on

the Edmund Rice Centre's website. Secondly, you need to write to your Federal MP and to Senator Evans, calling for an urgent reopening of the cases of the asylum seekers removed to danger from Nauru. Australians urgently need to encourage the Government to continue with immigration reforms. Finally, this work is desperately difficult to resource and yet urgently needs to continue. ## **BISHOP CALLS FOR HALT TO WA GAS HUB**

Indigenous groups have not been adequately consulted on the development of a gas processing hub on Western Australia's Dampier Peninsula, says Bishop Christopher Saunders. ABC News reports Bishop Saunders has backed statements by Indigenous groups and environmentalists that public consultation over the project has not been wide ranging. Bishop Saunders said that Aboriginal people on the peninsula have told him they regret going along with the proposal in the past. ## **2008 HUMAN RIGHTS MEDALS AND AWARDS**

The President of the Australian Human Rights Commission, the Hon. Catherine Branson QC, has announced the shortlisted entries for the 2008 Human Rights Medals and Awards. The awards are held annually to coincide with International Human Rights Day on 10<sup>th</sup> December. This year's awards ceremony also celebrates the 60th anniversary of the Universal Declaration of Human Rights passed by the United Nations in 1948. ## **PUBLICATION - 'HUMAN RIGHTS OVERBOARD'**

In 2005, in the wake of the Cornelia Rau scandal, a citizen's inquiry was established to bear witness to events in Australia's immigration-detention facilities. Until then, the federal government had refused to conduct a broad-ranging investigation into immigration detention, and the operations within detention centres had been largely shrouded in official secrecy. The Inquiry heard heartbreaking evidence about asylum-seekers' journeys to Australia, their refugee determination process, and their life in and

after detention. Authors Linda Briskman & Susie Latham & Chris Goddard have drawn together the oral testimony and written submissions from the inquiry in *Human Rights Overboard*, which stands as an indictment of Australia's refugee policy. Fr McCoy explores issues of masculinity, of grief, of illness, and how these relate to *kanyirninpa* (holding, nurturing, teaching, growing-up, respect). It is a book about an ancient culture and its people, trying in their own way, to survive in 21st century Australia. ### Service providers seek help

Major church providers called for a crisis and recovery fund from the Australian Government to ensure people who are doing it tough due to the impact of the global financial crisis are not further disadvantaged.

Pope Benedict made a plea for more action to address the poverty, conflicts and neglect that lead to the suffering or death of millions of children around the world.

### "New generation" political education a must: Pope

Formation for a new generation of "lay Catholics involved in politics" is urgent and vital, Pope Benedict said.

### Asylum seeker exposé draws huge response

An SBS television documentary featuring an Edmund Rice Centre exposé on the treatment of rejected asylum seekers drew a huge response, ERC director Phil Glendenning said.

### Breaching laws hit families: CSSA

Harsh social security breaching laws impact on families with up to 50 percent of breached job seekers falling behind in their rent, Catholic Social Services chief Frank Quinlan told a Senate enquiry.

### **Catholic Healthcare pilots squalor phone hotline**

Catholic Healthcare launched a Sydney telephone hotline to coordinate responses to people living in domestic squalor.

### **ERC backs Palm Island Royal Commission call**

The Edmund Rice Centre backed a petition calling for a Royal Commission into the events surrounding the death in custody of Palm Island man Mulrunji Doomadgee.

### **Bishop Saunders calls for “stay of execution” over WA gas hub**

Saying that indigenous groups had not been adequately consulted, Broome Bishop Christopher Saunders called for a “stay of execution” over the development of a gas processing hub on Western Australia’s Dampier Peninsula.

### **Vatican denounces Congo “massacre of the poor”**

Describing recent events in the Democratic Republic of the Congo as a “massacre of the poor”, Vatican spokesman Fr Federico Lombardi called for world support to end the violence and assist refugees.

### **Human rights “atomised”: Gleeson**

Retired High Court Chief Justice Murray Gleeson criticised human rights trends favouring individual liberty and self-expression over family and community values.

### **Religious groups mobilise on climate change**

Indigenous leaders from Australia and the Pacific called on Australia to show leadership on climate change and Australian religious leaders are also mobilising on the issue.

### **Grech calls for review over Down’s Syndrome visa rejection**

ACBC immigration spokesman Bishop Joseph Grech called for a review of immigration procedures following a government decision

to deny a German doctor permanent residency because his son Down’s Syndrome.

### **Rudd launches Ozanam learning centre**

Prime Minister Kevin Rudd opened the new Vinnies sponsored Ozanam Learning Centre in Woolloomooloo, Sydney, which aims to empower and equip homeless people in a transition back to “sustainable independent living”.

### **Indigenous crisis for boarding schools**

Catholic boarding schools catering for indigenous students in Queensland and the Northern Territory may lose up to 30 percent of their grants if legislation currently before Federal Parliament is passed.

### **Don’t kill Bali bombers: Rush priest**

Brisbane priest Fr Tim Harris, who just visited two former parishioners, convicted drug mules, Scott Rush and Michael Czugaj, said that the death penalty is not the answer for drug traffickers or for the Bali bombers.

### **Congo crisis appeal**

Caritas Internationalis launched an appeal for peace and for aid to be delivered to the crisis torn east of the Democratic Republic of the Congo.

### **Aussie Christian Brother leader to head PNG disability network**

The Christian Brothers announced the appointment of their former Western Australian leader, Br Kevin Ryan, as the new director of a national disability services network in Papua New Guinea.

### **Asia-Pacific Catholic women seek empowerment**

Catholic women’s organisations in the Asia-Pacific will focus their energies on empowerment for women, a regional conference in Seoul decided.
