### FROM THE SECRETARIAT

Dear Friends,

This is the 100<sup>th</sup> issue of the ACSJC Monthly Briefing!

I would like to take this opportunity to thank you for receiving this Briefing over the years - for your keen interest in issues of social justice and for your commitment to advocacy and good works for justice, development, and peace.

In April 2000, the Australian Catholic Social Justice Council issued the first Monthly Briefing. Prior to that the Council issued 'Network Notes' to its Diocesan Contacts around Australia. It was in 1999 that the Council decided that this newsletter should also be provided to social justice groups and interested individuals beyond this network. And it has evolved since then.

The aim of the Monthly Briefing has always been to provide updates on action for

social justice, notice of coming events, new resources and ideas for action. It aims to encourage information sharing between diocesan and national levels and among broader social justice groups of the Church and society.

I think of the range of issues and momentous world events that have been addressed in these Briefings since April in 2000. The Great Jubilee and the expectation of a new millennium for overcoming violence, the Decade for a Culture of Peace, and the Millennium Development Goals. The 9/11 terrorist attack, the military invasions and undermining of civil and political rights in the so-called 'war on terror'. The 'Tampa' incident and Australia's treatment of asylum seekers under the 'Pacific Solution'. The hard slog for Reconciliation, the NT Intervention and Prime Minister Rudd's National Apology to the Stolen Generations and all Aboriginal and Torres Strait Islander peoples. The participation of women in the Catholic Church in Australia. The call for ecological conversion. Issues of affluence and poverty and the impact of tax reforms, social security policy and unjust workplace legislation.

These are just some of the issues. They are like signposts that highlight the commitment of individuals and agencies working for justice and for the restoration of the human dignity of those who are most vulnerable or dispossessed in Australia and around the world.

Fundamentally, the ACSJC Monthly Briefing is a resource that seeks to enable people to take up issues of justice.

I am very grateful for all those people and organisations who send information about resources and forthcoming events for inclusion in the Briefing. I would welcome your support in further promoting the Briefing among your networks and institutions.

Let me recall the words of Sandie Cornish, when she issued the first Briefing in April 2000:

“As we enter the 21<sup>st</sup> century (or not yet, depending on how you count it!) we are getting a bit more techno savvy. Our website [www.socialjustice.catholic.org.au](http://www.socialjustice.catholic.org.au) is quickly taking shape and our old paper, monthly Network Notes to Diocesan Contacts, has morphed into an email bulletin ... Please drop us an email with news of your activities for inclusion in the bulletin. There’s nothing like concrete local action to inspire others!”

### **REFUGEE WEEK GRANTS (NSW)**

Refugee Week will take place this year from 14 - 20 June. To encourage community groups and organisations to hold events and functions, the Refugee Council of Australia and the NSW Refugee Week Committee will be offering a limited number of small grants of \$250 and \$500 each - made possible through the generous support of the NSW Community Relations Commission. The grants are designed to enable grass-roots community

participation in events that include refugee communities. Events should reflect this year’s theme, ‘Freedom from Fear’. The aim is to encourage Australians to think about the reasons refugees flee their homes, the fear they might experience at arriving in a new land, and the importance of providing safety and lasting security to people who have lost everything. ### **LAUNCH OF NGO GUIDELINES RE PEOPLE TRAFFICKING**

In early March, Catherine Branson QC, President of the Australian Human Rights Commission, and Jennifer Burn, Director of the NGO Anti-Slavery Project, launched Guidelines for NGOs assisting victims of people trafficking deal with and recover from the trauma. The practical resource covers key issues including: gaining informed consent from a victim before taking action on their case; protecting the privacy of victims and treating their cases confidentially; the importance of providing culturally appropriate services; and the requirement that service providers must also meet professional/occupational standards and codes of conduct. The Guidelines were

developed by a Working Group, including the religious orders, established at the first meeting of the National Roundtable on People Trafficking in June 2008. They can be accessed at <http://www.ag.gov.au/peopletrafficking>

#### **PETITION - RECOGNITION FOR EAST TIMOR**

The Mary MacKillop East Timor Mission has announced that it will nominate the nation of Timor-Leste for the award of Companion of the Order of Australia (Honorary) in recognition of the unique contribution of the Timorese people to Australian soldiers during World War II. Sister Susan Connelly from the Mary MacKillop Mission says that the Australian veterans who fought on Timor in World War II remember the Timorese people with deep gratitude and that for the last seventy years they have told and retold the stories of the courage and compassion of the Timorese. #### **RECONCILIATION AUSTRALIA - 'CHALLENGING STEREOTYPES'**

A new advertising campaign challenges Australians to rethink negative stereotypes of Aboriginal and Torres Strait Islander people. Developed as a community service announcement, the Reconciliation Australia campaign is informed by the Australian Reconciliation Barometer—groundbreaking research that explores our attitudes to each other as Indigenous and non-Indigenous Australians. Findings of the research show: there are equally low levels of trust between Indigenous and non-Indigenous Australians; there is low recognition of Indigenous achievement outside of high profile successes in sport and the arts; and Australians overall rate themselves ahead of Indigenous people in possessing positive qualities like a sense of humour and being welcoming and hard working. The advertising uses real people with headlines that confront stereotypes around substance abuse, unemployment, child care, professional achievement, who is Aboriginal and crime. ## AHRC PUBLICATIONS

Three releases from the Australian Human Rights Commission are now online. The first is about the Australian Human Rights Commission's concern with the Law Enforcement (Powers and Responsibilities) Amendment (Search Powers) Bill 2009 (NSW). The Bill, if enacted, would significantly extend the power of police to conduct covert searches. ## NEW DVD - JOINING HANDS

Students and staff from Aranmore Catholic College in Perth have been involved in the development of a resource designed to give African students of refugee background a voice in their educational experience in Australia. Produced by the Association for Services to Torture and Trauma Survivors (ASeTTS), the DVD is entitled *Joining Hands - Connecting African students, their families and WA secondary education*. It will assist schools to meet the specialised education and personal support needs of this group of students and highlights also the great strengths of these young people. ## AUSTRALIA INSTITUTE PAPERS

The recently released Australia Institute Report *The great superannuation tax concession report*, highlights that current superannuation

tax concessions flow overwhelmingly to those who are well off, with the top five percent of individuals accounting for 37 per cent of concessional contributions.

Another paper, *Increasing the Newstart Allowance*, calls for increases to allowance rates as a necessary part of equitable fiscal stimulus and shows how the well off are set to benefit from foreshadowed tax cuts in July 2009 and July 2010 - with modest cuts going to those on incomes higher than \$34,000 per annum and greater cuts going to those on incomes over \$80,000 per annum.

A National Human Rights Consultation was announced by the Attorney-General Robert McClelland on Human Rights Day (10 December 2008). 1. Which human rights and responsibilities should be protected and promoted?
2. Are these human rights currently sufficiently protected and promoted?

### Multifaith Earth Hour vigils this weekend

The Australian Religious Response to Climate Change organised a series of multi-faith vigils in Sydney, Adelaide and Brisbane in support of Earth Hour, while China's Baoding Catholic diocese promoted the event as part of Lenten abstinence.

### Multifaith march for Muslim prayer room at RMIT

Socialists, Jews and Christians joined Muslims in a Melbourne city protest march over RMIT student demands for more dedicated Muslim prayer rooms rather than more multifaith facilities.

### Men responsible for prostitute abuse: Hickey

Banning brothels in residential areas would be a welcome first step to curbing prostitution but laws need to go further by making it illegal to pay for sex, Perth Archbishop Barry Hickey said.

### Vatican UN rep warns against religious intolerance

Holy See permanent observer at the United Nations, Archbishop Silvio Tomasi, expressed concern at the UN Human Rights Commission over increased intolerance against Christians, not only in countries where the religion is a minority, but also a majority.

### **Napier slams Dalai Lama South Africa visa denial**

Durban Cardinal Wilfrid Napier expressed “shock and regret” that the Dalai Lama, Tibet’s exiled spiritual leader and head of its self proclaimed government-in-exile, was denied a visa to attend a peace conference in South Africa.

### **Washing machine trumps pill for liberation: Vatican**

The washing machine had a greater liberating role for women than the contraceptive pill, according to a L’Osservatore Romano commentary on International Women’s Day.

### **Philippines church condemns anti-mining activist murder**

Marbel Bishop Dinualdo Gutierrez condemned the killing of an anti-mining environmentalist and human rights advocate working in partnership with his diocese to oppose the development of the giant Tampakan mine.

### **Caritas slams abortion aid decision**

Caritas Australia CEO Jack de Groot endorsed concerns expressed by Prime Minister Kevin Rudd over changes by Foreign Minister Stephen Smith, a Catholic, to the Australian aid program that will allow funding of abortions.

### **Hickey fears new stolen generation**

Perth Archbishop Barry Hickey questioned child welfare policies, saying at risk Aboriginal children are often placed with dysfunctional relatives and warned of a new stolen generation.

### **100,000 face annihilation: Sri Lankan bishop**

Jaffna Bishop Thomas Savundaranayagam warned that more than 100,000 Sri Lankans face “total annihilation” unless an evacuation of Sri Lanka’s north-east war zone begins immediately.

### **Religious leaders pressure PM on climate change**

Over 60 religious leaders including Oceania bishops conference president, Bishop Peter Ingham, wrote to Prime Minister Kevin Rudd to express their deep concerns with the Government’s “inadequate” response to climate change.

### **Hickey’s home a haven but more needed**

Perth Archbishop Barry Hickey’s home become a haven for homeless people, many of whom are indigenous, looking for emergency accommodation but much more needs to be done, he believes.

### **Rwandan ex-priest gets 25 years for genocide role**

The International Criminal Tribunal for Rwanda sentenced former Rwandan Catholic priest, Emmanuel Rukundo, to 25 years imprisonment for crimes against humanity relating to the 1994 genocide.
